432. ARM Super Shot safety alert

A safety alert has been issued by A.R.M. (USA) Inc. relating to its Super Shot ride. This highlights a defect on the device's structural tubes resulting in the potential misalignment of the brakes. Please see the accompanying alert.



ABSTRACT OF ISSUE	All	
Immediate inspection of tower structure for indications of damage to tube members.		
REASON FOR RELEASE		
A.R.M. (USA), Inc. has been made aware of structural tube deformation on at least one mobile tower resulting from poor lift hook maintenance and improper engagement of the hooks when lifting the passenger carriage.		
ACTION TO BE TAKEN		
Immediate inspection of all tower structural tubes with emphasis on the four corner vertical tubes that the passenger carriage guide wheels contact. Any collapse of the tube walls or corners to be measured and reported to A.R.M. (USA), Inc. prior to continued operation.		
Tower inspection to be repeated on a regular basis, no less than monthly, and after any irregular operation of the lift hook system.		
DETAIL OF ISSUE		
Precise alignment of the magnetic breaking system is crucial for safe operation and requires accurate tracking of the guide wheels along the tower frame. Collapsed portions of the tower frame tubes will allow the passenger carriage to shift on the tower resulting in misalignment of the magnetic breaks in relation to the conductor rails affixed to the tower. Even slight misalignment will alter the performance of the magnetic brakes - and possible failure.		
In the event that the lift trolley hooks are not properly engaged to the passenger carriage, the carriage will be lifted on one side only - thus causing disproportional forces on the guide wheels around the carriage and trolley frames. The excessive force on the wheels will gradually deform the walls and/or corners of the vertical tube members on the tower.		
In addition to potential brake failure, any tube deformation effects the structural integrity of the tower itself.		
Prior to continued operation, all tower corner tube members must be visually inspected for deformation, excessive wear, cracks or other damage. The depth of any collapsed portion of the tube members to be measured and reported to A.R.M. (USA), Inc. for review and possible repair advise.		
Under no circumstances shall the ride operate with damaged tower tube members unless authorized, in writing, by A.R.M. (USA), Inc.		
It is also recommended that the lift hooks and related components be inspected for excessive wear, proper alignment and balanced engagement to the passenger carriage. Proper maintenance and operation of the lift hook system will prevent structural damage and ensure safe operation.
